At its next four meetings, the Sustainability Advisory Council (SAC) will prioritize focus areas for sustainability at UW-Madison. Here is the schedule:




December 2020	Academic & Research focus areas
January 2021	Engagement focus areas
February 2021	Operations focus areas
March 2021	Planning and Administration focus areas





The focus areas identified (so far) for our January meeting are in Table 2. These were identified through a review of peer best practices, results of UW-Madison’s Sustainability Tracking, Assessment & Rating System (STARS) report, Office of Sustainability staff experience, and feedback from the campus community during public listening sessions.

Additional focus areas may be defined by the SAC members. Before initial prioritization, the SAC will review, discuss, and identify resources that support the implementation of initiatives or challenges that could stall initiative progress.

<ul style="list-style-type: none"> <li>• <b>Campus as a Living Lab:</b> Living lab activities foster engagement and collaboration internally between operations staff and academics students/faculty/staff</li> <li>• <b>Sustainability Institute:</b> An Institute could act as a hub for internal engagement, student organizations, and community events</li> <li>• <b>Sustainability Courses:</b> Efforts in this focus area could include support for the development of sustainability-related continuing education courses</li> <li>• <b>Sustainability Learning Requirement:</b> Sustainability student onboarding could fulfill a sustainability learning requirement</li> <li>• <b>Honors &amp; Recognition:</b> Recognition can also include achievements in internal and external engagement</li> </ul>
